CONFRONTING DOMESTIC VIOLENCE IN MCHENRY COUNTY

A Message from the Director

Greetings everyone! We have had a very exciting year at Turning Point. We have been able to bring to fruition several service enhancements which will help us navigate our increasing client numbers. For one, Turning Point has secured an agency vehicle to provide transportation for clients to, for example, medical or court appointments. With one employee covering the shelter, there has been no possibility of a staff member leaving to transport a client to an appointment, or buy groceries for shelter. The acquisition of the vehicle, coupled with increased shelter staffing has already had a



positive impact on our shelter clients. Transportation has always been a significant barrier for our clients and we are pleased to be able to address this at last.

This past year we have also expanded our shelter staff to allow for two employees overseeing shelter at all times where previously we had only had one. Additional staff will not only aid in managing day-to-day shelter operations, but it will also allow the shelter to fully operate our 24/7 domestic violence helpline. At present, direct-service staff fill helpline shifts all day, every day and there are stipends paid out during weekends and holidays. Double staffing the shelter allows us to move away from the stipend expense while having more adequate coverage at the shelter.

Turning Point has also revamped our Transitional Housing program in order to accommodate more survivors in need of short-term affordable housing. The agency owns a two-flat residence in McHenry County which has recently been updated and is ready to receive single survivors or small families in need of a fresh start. The intention of the program is to house those who are not quite ready to be on their own and who may not qualify for other housing programs. Though not a new resource, we will now be in a position to help more survivors.

Finally, Turning Point's legal advocacy office at the McHenry County courthouse has been expanded in response to increased demand for services. For years, legal advocacy staff have worked in very tight quarters, trying to assist clients who come in for help with orders of protection while maintaining their privacy. Due to space limitations, clients were required to wait in the hall outside their tiny offices until it was their turn. The office has moved into a more spacious area where legal advocates and their clients have access to a private office at any given time. It is much easier to maintain confidentiality and comfort for all involved.

Turning Point has a talented and creative staff and board of directors whose dedication to survivors of domestic violence never ceases to impress me. In order to provide the best services possible, we require financial support. I hope you will consider Turning Point in your charitable giving plans.

Our Programs

24-hour Domestic Violence Helpline

• (815) 338-8081

Safe, Secure 24/7 Emergency Shelter

• 30 to 60 day stay for survivors actively fleeing domestic violence or homeless as a direct result

Individual and Group Counseling

• For children, teens, and adults

Trauma-Based Mental Health Services

• Psychotherapy for victims of domestic violence who have experienced childhood or lifelong trauma and abuse. This is not a free service, fees will apply.

Legal Advocacy

• Assistance filing orders of protection through our remote office at the McHenry County Courthouse.

Partner Abuse Intervention Program (PAIP)

• 26-week psycho-educational program designed to help clients identify abusive behaviors in their relationships and learn new skills to resolve conflict successfully.

Survivor's Intervention Program (SIP)

• Designed for people who have been violent in their relationship but have not been identified as the primary aggressor.

Positive Parenting Interventions (PPI)

• Intended for the treatment and Prevention of Child Abuse and Neglect. Sliding scale fees. Court, agency referral, or voluntary.

Outreach and Prevention

• Free presentations on healthy relationships, bullying, intimate partner violence, and Turning Point, Inc. services for children, teens, and adults.



All of our domestic violence services are free and are offered in both English and Spanish



Revenue and Expenses


Financial Reporting Period of July 1, 2022-June 30, 2023



2023-2027 Strategic Plan

The Turning Point, Inc. Board of Directors agreed that it was important for the organization to engage in a formal strategic planning process. Multiple individuals were interviewed and ultimately MRA was selected as a consultant to help guide staff during this process. Key staff and board members were interviewed as well as outside stakeholders from other community organizations, courthouse personnel, judges, the police, city officials and donors.

The primary conclusion from these interviews was that Turning Point does very well in addressing the needs of clients short-term but needs to improve services to address more long-term needs. An internal committee was then formed that included the executive director and supervisors from the development, outreach and the adult domestic violence teams. This committee spent several months, in conjunction with MRA, developing a formal strategic plan for Turning Point that included a strengths, weaknesses, opportunities and threats (SWOT) analysis.



The committee and MRA presented this formal plan to the board on September 24, 2022. During this day-long process, the board also reviewed existing programs and other key initiatives that are currently underway and as a result, these initiatives were not included in the strategic plan.

The board formally adopted this strategic plan on October 27, 2022 and established organizational goals for 2023-2027.
